1. This Authorization has been issued under Chapter 5 of the Foreign Trade Policy 2015-20 and carries an export obligation to make physical exports to GCA countries or to render services (as defined in Para 9.50 9.51 of FTP), as the case may be, and realize the export proceeds in freely convertible currency. Deemed exports as specified under Para-7.02 (a), (b), (c), (f) and (h) of Foreign Trade Policy is also allowed.

2. The issuance of the Authorization shall be subject to the conditions/parameters as laid down in Chapter 5 of the Foreign Trade Policy 2015-20 and Handbook of Procedure 2015-20.

3. This Authorisation will be operative as per the provisions of Foreign Trade Policy and Handbook of Procedure 2015-20 or as per any other law/provisions for the time being in force.

4. This Authorization shall be utilized in accordance with the provisions of the Foreign Trade Policy 2015-20 and the concerned Customs Notification No. 016/2015 dated : 01.04.2015.

5. Capital Goods as defined in Para 9.08 (read with Para 5.01) of Foreign Trade Policy 2015-20, only shall be allowed for imports/domestic procurement against this Authorization.

6. The Authorization Holder shall be under obligation to Export Item as per details given below:

7. The Export Obligation shall be worth US\$ 204,169.79 i.e. 6 times of the duty saved on import of Capital Goods on FOB basis within a period of 6 years (Block Year 1st to 4th year - 50% and 5th to 6th year - 50%) reckoned from the date of issue of this Authorization. The Authorisation holder shall furnish proof of exports within 90 days of completion of each block.

8. Export Obligation shall be fulfilled by the authorisation holder through export of goods which are manufactured by him or his supporting manufacturer / Services rendered by him , for which the EPCG authorisation has been granted.

9. Authorization Holder shall also be required to maintain Average Level of Exports achieved in the preceding three licensing years for the same and similar products mentioned in Para 6 above. The annual average of the past export performance to be maintained by the Authorization Holder is Rs. 443,159,275.00.

10. The Authorization Holder may discharge the export obligation by way of direct exports as well as through third party exports. EPCG Authorisation number and date shall be mentioned on all export documents of shipments pertaining to EO fulfilment of the EPCG Authorisation.

11(a) In the event of third party exports, name of the third party exporter, name of EPCG Authorization holder and supporting manufacturer, if any, number and date of EPCG Authorization shall also be indicated in the Shipping Bills, BRC, GR declaration, export order and invoice shall be in the name of third party exporter. The goods exported through third party shall be manufactured by the EPCG Authorisation holder or the supporting manufacturer where the capital goods imported under the authorisation have been installed [Para 5.10(c) of HBP, 2015-2020]. In such cases, the authorisation holder shall submit the additional documents prescribed in Para 5.10(d) of Handbook of Procedures, 2015-2020 at the time of final redemption.

(b) Deemed exports as specified under Para 7.02 (a), (b), (c), (f) and (h) of Foreign Trade Policy shall also be counted towards fulfilment of export obligation

12. The Authorization holder shall have to fulfil export obligation as per Para 5.04 of Foreign Trade Policy read with Para 5.10 of the Handbook of Procedure 2015-20.

13. In case, authorization holder has supporting manufacturer(s), the name of the supporting manufacturer(s) shall also be indicated in Shipping Bills.

14. Import/Procurement of capital goods under this authorization shall be subject to Actual User Condition.

15. Import/procurement of second hand capital goods are not allowed under EPCG Authorization.

20. Besides the above conditions, the issue of Authorization shall be subject to all other relevant conditions/parameters of Foreign Trade Policy and Handbook of Procedure (2015-20). Any violation of this, shall be subject to penal action as envisaged in FTP/HBP and FT (D&R) Act.
