Kindly note that the shipment was ported out on 22.07.2022, and as per the general procedure, was submitted for sample drawing to the health ministry food inspection unit on 23.07.2022. However, unfortunately, the food inspection unit detained 5 containers stating that the sample result turned out as failed (refer trailing email for the detained container numbers). The failed result is also attached herewith FYR. We are in the process of requesting for resampling. However, kindly note that if the resampling result also turns out as failed, we will have to reship this back to you for which the cost will have to be borne from your end. Shall keep you posted on any further developments.



We understand your concern, however, kindly note that the decision of the authorities is considered final. We do not draw samples for them, they randomly draw samples and carry out the tests as per the standard procedure. As for the Aflatoxin test report provided by you, we have shared this with the relevant authorities at the point of clearance. Eventhough I have mentioned the word "resampling" earlier, it is more of a retesting that will be done by the authorities. Meaning, the same sample picked previously by them will be retested. This is beyond our control as it is standard procedure. Therefore, all we can do is request for a retesting and await their final result. We will keep you updated on this.

My Dear Madam,

Apropos your kind mail of yesterday and from your Manager Procurement & Cost Optimization Mr Yohan, I'm presenting our stance alongside suggesting the approach to overcome this frequent hurdle at Colombo.

I draw your kind attention to the fact that since beginning, our order is for medium quality dried red chili at a commensurate price and we have been shipping the appropriate quality. We scrupulously comply with the Indian Government stipulated pre-shipment testing by internationally accredited laboratories viz Bureau Veritas, NAWAL Analytical Laboratories and our chili shipments are allowed for exports only after the nod from Spices board, which is the chief Govt authority to regulate the chili exports from India. These certificates are issued with particular reference to norms of imports into Sri Lanka.

Our consignments which are in imbroglio now are certified by the Indian Govt bodies after rigorous testing about the aflatoxin levels. Please note these results are at the time of shipping from the load port in India.

Our responsibility is to supply the ordered quality and get the requisite and genuine certificates issued by the nominated Govt authorities and effect the shipments and we do it judiciously. These stringent checks before allowing the chili shipments are done only to totally avoid any rejection at destination that would entail untold losses and inconvenience to both of us. We fulfill our responsibility in all respects at load port.

From the fact that many chili consignments including those of our customers get passed by Sri Lanka health authorities and some get rejected, even from the same lots of goods is a pointer to the arbitrariness in evaluating the parameters at destination side. There are many factors that may affect the attributes of chili consignment from the time they go onboard till reaching destination like weather conditions, long stay inside the closed containers etc and such fluctuations in aflatoxin levels are only temporary and natural, since they are taken of the samples drawn from the immediately opened containers. Once goods are placed in well ventilated and airy stockyards, the goods will regain the quality attributes that were present at the time of loading. Because of this genuine reason, we exhort our buyers to provide equivalent samples from outside which will surely pass the tests and obviate the risks of rejections which are only knee-jerk reactions from the authorities there.

Agro products are susceptible to several factors and no one has control over the inevitable changes they go through and these changes cannot be predicted. For a company of your stature, irrefutable reputation and contribution to the country's economy and GDP, I sincerely request you to use the goodwill, rapport and good offices with appropriate authorities to get all the chili consignments cleared quickly to pave the way for smooth trade between our companies from now on and well deep into the future.

It is with great regret that we inform you that the retesting result also turned out to be rejected. The report received is attached herewith FYR. As per the general procedure, if the initial sample testing result turns out as failed, then the sample will be retested (upon request) by a government authority (the result they provide will be final). If that too turns out as failed, then there is no option but to reship the goods back. Therefore, we have no option but to reship **ASLU7002772**, **ASLU703634**, **ASLU7034403**, **ASLU8005927**, **ASLU7034276**.

There are two options for reshipping.

Option 1 - A new shipment of the same quantity can be arranged on FOC basis as the bank has already released the payment. Option 2 - Refund to be made to Convenience Foods Lanka PLC for the proportionate value of invoice amount USD 145,901.25/= on or before 30 days of reshipment BL date (quantity replacement not required). Refer below table for the amount computation.



My Dear Madam,

This has reference to your kind mails intimating us about the test results of 10 fcls of dried chili consignments which we had shipped to your esteemed company in different lots and at different times in the recent months. We assert that we have done all our chili shipments in total compliance with the quality clauses stated in the proforma invoices which were approved at your side including the nominated government authorities of Sri Lanka, based on which the letters of credit were issued by your bank which contained the certifications required for the shipments at the load port. Your company ordered dried chili - medium at the commensurate price and we had judiciously supplied them. All our shipments were subjected to the quality inspection by none other than the Government of India's Spices Board and passed by them for aflatoxin levels and the results and the test methods were given clearly in the certificates issued by them. As an exporter, what is required and possible to do, we have complied with the strictly laid rules in consonance with the rules of the importing country at the time of loading and we have produced all the genuine certificates to you through your bank to establish beyond any doubt that we have shipped the right quality at the right aflatoxin levels as unequivocally certified by the Spices Board, Government of India as required by the Food Control Administration Unit (Ministry of Health), Sri Lanka.

As regards the test results at the destination port, we find them inconsistent, arbitrary and erroneous. Whether the same methodology of testing is adopted or not, the results of the test conducted by SGS (which is only optional as per general procedure as you mention) and of the test conducted by the Ministry of Health, Sri Lanka (which is the ultimate authority and whose result is final) are grossly mismatching with both increase and decrease in findings from test 1 to test 2. Such abnormal variations in test results are dubious and cannot be the yardstick for rejecting the consignments which are passed by the Spices Board, Government of India which is the designated authority by the Food Control Administration Unit (Ministry of Health), Sri Lanka. As you are aware, Spices Board, Govt. of India wrote a specific letter to Ministry of health, Sri Lanka they have passed all our shipments after duly testing them and after pointing out the huge differences in the

results between the 2 tests, recommended for another test before any decision was made by MOH, Sri Lanka. Till this message is written now, there was no reply from MOH.

When testing first with SGS is only optional there and not mandatory, from your statements in the mails dated 6th and 10th that we should plan our shipments with ETAs during the 1st fortnight of each month to avoid SGS, it is clear that their results are prejudiced and therefore your company should have avoided testing it with SGS.

If either of the results are considered for accepting or rejecting the consignments, both the optional SGS and the mandatory MOH laboratory must have submitted the samples for tests on the same day and the tests should have started and completed on the same dates to apply the concept of " level playing field" based on which the fate of the consignments should have been decided. But this crucial point was not followed there. There was an average gap of above two weeks from the date of drawing the sample and subjecting them to tests with MOH lab. The sample drawn by the MOH was kept in LDPE pouches from the time of drawing the sample to the time of testing with MOH lab and such unkind and inappropriate preservation of sample will certainly aggravate the results as agro products are vulnerable to unsuitable preservations. We invite your kind attention to the results of the container no. ASLU7034276 where the aflatoxin level has come down from 111.80 by SGS to 33 by MOH which was done after a lapse of 12 days since the sample drawn date. Had the test by MOH been conducted on the same day when the sample was drawn, the MOH result would have been lower than 30 and the shipment would have been passed. We take exception to the procedure being followed by MOH based on which casual decisions were made without realising the dire consequences faced by the exporters and importers. We are contemplating legal action against the defective testing modus operandi of MOH.

As regards the further course of actions, you have retired our documents from your bank (State Bank of India, Colombo) and therefore the title of ownership is transferred to you already and irrevocably. As we understand from the rules and regulations of Sri Lanka customs, as the owner of the goods, you are permitted to freely re-export to any destination, anywhere and buyers of your choice. In case you wish to re-export to India to our name, we shall endeavour our very best to clear the consignments, sell them and only then will be able to return the realised proceeds to you. We understand from one of your recent conversations with our Mr Raja that you have stopped our payments for 26 fcls by writing to your bank and ICFCU and they have also not paid our bills for 26 fcls despite our shipments being done under documentary credits.

We assure you of our support to get over this issue and we look forward to receiving your kind reply to pursue further.

We had supplied dried red chili vide subject shipments to your company as per your order and prior to the shipments all our subject consignments had passed through the tests done at load port, which are alone mandatorily required by Food Administrative Control Unit, Ministry of Health, Sri Lanka for aflatoxin by the Spices board, the highest official authority in India for the export of dried red chilies.

Since the subject consignments were rejected by Ministry of Health, Sri Lanka based on the results of 2 tests done at destination, Colombo, with the same sample but at varying times, showing inadmissible aflatoxin levels, we have already explained to you that it is not possible to clear the said consignments when they are re-exported to India to anyone.
